WAIVER AND RELEASE AGREEMENT

Please read carefully before signing. This is a release of liability waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of dog agility training, I agree to the following Waiver and Release: I acknowledge that dog agility training has inherent risks, hazards and dangers that cannot be eliminated. I understand that these risks, hazards and dangers include without limitation:

1. Walking, trotting and running on uneven ground.
2. Inclement weather conditions.
3. The unpredictable nature of dog behavior.

I understand the risks, hazards and dangers as described above and have had the opportunity to discuss them with *4 Dognite Agility Training*. I believe I have the physical conditioning and the degree of skill and coordination for me to engage in these activities safely. I understand that I have responsibilities to control my dog around other people and dogs. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I am voluntarily using the services of *4 Dognite Agility Training* with full knowledge of the inherent risks, hazards and dangers involved and I accept any and all risk, hazards and dangers.

I, for myself, my heirs, successors and executors, hereby knowingly and intentionally waive and release, indemnify and hold harmless *4 Dognite Agility Training*, their directors, officers, employees, and volunteers from and against any and all claims, actions causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss or injury to me or my property as a result of my engaging in these activities or the use of these services or equipment.
